

### Article III Motorcycle Week Vendor License Requirement

#### Section 11-32 Definitions:

**VENDOR:** all persons, both principals and agents, including those persons whose principal place of business is not in this state, who engage in the temporary or transient business in this state, whether in one locality or traveling from place to place, selling goods, wares and merchandise from stock or buying samples for future delivery and who, for the purpose of carrying on such businesses, hire or occupy a temporary place of business, on property not owned by them. This definition does not include non-profit entities soliciting for donations in furtherance of its nonprofit purpose.

#### Section 11-33 Application Procedures and Requirements

- A. All vendors intending to engage in business during Motorcycle Week must apply for and obtain a license from the town.
- B. Motorcycle week licenses are valid for a 10 day period that begins on 12:00 noon on Friday of the first weekend of Motorcycle Week and ends at 12:00 midnight on the Sunday of the second weekend of Motorcycle Week. Applications are available at the Town Manager's office.
- C. Applications must include the nonrefundable application fee as determined by the Board to cover the cost of administering these regulations as well as the cost of the town to provide the necessary resources to keep the public safe during Motorcycle Week, including but not limited to, law enforcement, fire protection, emergency medical services, public health, traffic control, and trash removal.
- D. Completed applications must be received no later than 14 days before the beginning of Motorcycle Week.
- E. Applicants must provide the location of the vending and written consent of the owner if the applicant is not the owner, the nature of the vending that will take place, a valid 24 hour phone number to reach the applicant during Motorcycle Week, and demonstrate that adequate on-site pedestrian circulation, adequate security, and measures for disposal of trash and sanitary waste collection occur throughout the event.

#### Section 11-34 Fees

The license fee is \$450.00

#### Section 11-35 Violations and Penalties

- A. Violations of this chapter shall be punishable by a fine of up to \$500, and each day during which a violation is committed or continued shall be a separate offense.
- B. Any license under this chapter may be suspended or revoked for any of the following reasons: fraud or misrepresentation in the application; fraud or misrepresentation in the course of conducting the business for which the license was issued; conducting the business in such a way as to create a public nuisance or to pose a threat to public health, safety, or welfare or in violation of any health or sanitation law or regulation or violating any of the terms of this ordinance.
- C. Applicants may appeal any violation or penalty within 10 days of receiving it to the Board of Selectmen, who at their next scheduled meeting will conduct a public hearing to review the violation or penalty, allowing the applicant to speak and rebut the evidence forming the basis for the violation or penalty.
- D. Decision of the Board of Selectmen shall be in writing, include the factual basis for upholding, modifying, or reversing the violation or penalty, and shall be sent via mail to the applicant.
